



Privacy Policy

This Privacy Policy ("Policy") explains how information about you is gathered, used, and processed by Quantenna Communications, Inc. and its subsidiaries (collectively, "Quantenna" "we," "our", or "us") when you visit <http://www.quantenna.com/>, other Quantenna websites accessible globally through this site, or other sites displaying this policy (collectively, "Websites").

Personal Data Collected

We collect different categories of personal data on our Websites, which may include personal and business contact information such as your name, company name, job title, contact number, physical and email address, relationship to Quantenna, job application information such as your work and education history, and other information you have provided or is required to process a transaction, service, inquiry or request. We may not be able to fulfill a request if we do not receive the data required.

Use of Personal Data Collected

We use the personal data you submit on our Websites to meet our legitimate business interests. This includes responding to your requests, inquiries, or otherwise serve you in ways associated with the circumstances under which you provided the information. We do not use your personal information for Quantenna's marketing purposes unless you affirmatively agree or opt-in to such usage. Marketing may include sending you communications about our products and services or other communications targeted to your interests. If you do not wish us to use your email address or other contact information for our direct marketing purposes, or if you initially agree or opt-in but change your mind, you can: (i) reply to a promotional email we have sent and indicate your preference to unsubscribe; or (ii) send us an email stating your request to info@Quantenna.com. For job applicants, Quantenna will only use personal information provided by job applicants for recruitment purposes.

Recipients of Personal Data

We may share your personal data collected through our Websites, on a need-to-know basis, with authorized persons within Quantenna or its affiliates involved in the above-mentioned purposes.



We may also disclose your personal data to third party providers (in particular, to enable them to execute certain web services for us, such as web hosting or maintenance services).

We reserve the right to disclose such personal data to any other third party if we believe that we are required to do so by law, including, where applicable, (i) to comply with legal processes or governmental requests; (ii) to prevent, investigate, detect or prosecute criminal offences or attacks on the technical integrity of the web site or our network; and (iii) to protect the rights, property or safety of Quantenna, the users of the Websites, or the public.

Information Collected Automatically

As you navigate through and interact with our Websites, we collect certain information that is automatically recorded from the computer, smartphone or other electronic device (“device”) you use to visit the site. This may include information about your equipment and browsing actions, such as your device’s Internet Protocol (IP) address, operating system, browser type, and web pages viewed immediately before and after visiting our Websites, information you search for on our Websites, and other technical data. We use browser cookies, which are very small data files transferred to your device, to collect information when you direct your browser to our Website; these include session cookies, which are deleted when you exit that enable certain Website features and help us understand how visitors interact with the Website. When you register for one of our web-based services, we may use persistent cookies to store information that enables our Websites to remember you on a return visit. These technologies also help us better understand which areas of the Website are of interest to visitors.

We use information we collect automatically through logging and cookie technologies for legitimate business interests, to facilitate your use of our Websites, to analyze usage by visitors, to improve user experience, and to deliver better service. You can adjust the settings on your Internet Browser to control cookies.

Minors

Our Websites are intended for a general audience comprised of adults. If you are a minor in your country of residence, you may use Quantenna Websites but only with the prior consent of your parent or guardian. We do not knowingly collect personal information from minors under the age of 13. If we learn that we have inadvertently collected personal information from a minor under the age of 13, we will delete the information to the extent required by applicable law.

International Transfers of Personal Data



Quantenna has operations and offices in multiple jurisdictions. International transfers of your personal data are covered by the applicable international data protection laws, codes of conduct or other protection mechanisms to ensure your personal data is provided an adequate level of data protection.

Your Rights

To the extent required by applicable law, you may be entitled to obtain information on the processing of your personal data, access your personal data, object to or restrict the processing of your personal data, make use of your right to data portability where applicable, and have your personal data rectified or deleted. You are also entitled to withdraw at any time the consent that you have given with respect to the processing of your personal data.
